MANDATORY REQUEST OF ORIGINALS OF SUPPOSEDLY MEDIUM-TERM LOAN AGREEMENTS AND OTHER RENTAL DOCUMENTS AND WITHHOLDING TAX CERTIFICATES & RECEIPTS FROM FIDELITY BANK GHANA LIMITED FOR A 3-DAY OFFICIAL PUBLIC INSPECTION TO BE HELD IN ACCRA

Respectfully, Your Excellency, Mr. President, I write this mandatory request of above stated ORIGINAL documents to be release by Board of Directors of Fidelity Bank Ghana Limited for a 3-day Official Public Inspection to be held in Accra, Ghana.

That as a follow-up of all of my Notices and Criminal Complaints submitted to Your good office with dates of March 4, 2017, September 4, 2017, January 1, 2018, January 25, 2018 and February 28, 2018 in relation to Fidelity Bank and its Board of Directors having fraudulently, maliciously and wrongfully manufactured Medium-Term Loan Agreements and other Loan Papers designed and implemented to seize and to takeover my Adwoa Adjeiwaa Building in Osu and my matrimonial home at Trasacco Valley, Accra.

That United Nations and United States Authorities have directed that I, Akwasi Boakye Osei, a Ghanaian National, permanently on Asylum in the United States, I should respectfully request that Your good office; Your Government Agencies (Security Agencies); the Bank of Ghana and the Media Outlets to

4. Proof of Payment of Rent to Landlord and Receipt of Payment Issued by Landlord Akwasi B. Osei to Fidelity Bank Limited
5. Proof of Originals of Ghana Revenue Authority Withholding Tax Certificates and Receipts (Period - February 1, 2013 to January 31, 2018)
6. Originals of Adwoa Adjeiwaa Building Title Documentation (Land Title Certificate) issued by Chief Registrar of Ghana High Court and certified by Ghana Lands Commission

I, Akwasi Boakye Osei, Landlord of Adwoa Adjeiwaa Building, do hereby state that I have granted Power of Attorney to my Uncle Mr. Isaac Acheampong to represent my interest in this Official Public Inspection of above stated Original Documents. That Mr. Isaac Acheampong shall agree with Fidelity Bank and its Board of Directors, Government of Ghana (Security Agencies), the Bank of Ghana and the Media Outlets as to which Hotel in Accra this Official Public Inspection shall take place.

That the Management of Ghana Must Know Program and Hot FM and all other Media Outlets shall announce the dates and venue of this 3-Day Mandatory Official Public Inspection of the said documents from Fidelity Bank Limited to be held early this month of May 2018.

Respectfully, Your Excellency, Mr. President, due to continuous misconduct of Fidelity Bank and its Board of Directors having falsely alleged in its **wrongful** Ghana Court Proceedings of January 11, 2017 and February 2 & 14, 2018, that this Official Public Inspection of above said documents shall bring clarity to the General Public, Government of Ghana, Bank of Ghana, United States Government and United Nations Security Council as to which party is telling the truth to Ghanaians and the rest of the world.
